#### STEPS TO PARTICIPATION

- 1. Complete and submit the following:
  - Registration Form
  - Facility Data Form
  - Request for Proposal
  - Include one of the following documents:
    - Resolution from local governing body
    - Tax exemption letter for 501(c)(3)
- 2. Evaluate the proposals you receive and submit a firm selection form with the associated documents. **After receiving approval**, execute a contract with the firm you selected, have the audit performed and submit the report.
- 3. After you receive approval of the final energy audit report, submit your:
  - Incentive Request Form
  - Final Energy Audit Report
  - Energy Audit Invoice

and we will process your incentive payment.

- 4. Implement the cost-justified energy efficiency projects recommended in your audit report and receive incentives from New Jersey's Clean Energy Program to offset your capital costs.
- 5. Enjoy your energy savings!

# INCENTIVES COVER 100% OF THE COST

Participants will select from a list of pre-qualified auditing firms who follow the strict parameters of *New Jersey's* **Clean Energy** *Program* to analyze your buildings and prepare the audit report. The program will subsidize 100% of the audit cost, subject to an annual \$100,000 incentive cap.

When your audit is complete, you'll have a list of recommended, cost-effective energy efficiency measures and facility upgrades that will reduce operating expenses and, in many cases, improve the health and productivity of the buildings' occupants. Many of the recommended measures are eligible for additional incentives through NJ SmartStart Buildings.

After the audit report is approved, you'll have a clear guide to upgrading your buildings to be energy-efficient, leveraging other NJ Clean Energy Programs for incentives, and saving you money!



## GETTING STARTED

Participants must submit Registration and Facility
Data Forms, which are available in the Guidelines to
the Local Government Energy Audit, found at
NJCleanEnergy.com/LGEA.

The guidelines package also includes a request for proposal template, sample resolutions for local governments, and contact information for the pre-qualified auditing firms.

In comparison to typical public bidding, local governments are able to streamline their process by requiring proposals within 10 business days. When the bidding is complete, use our sample template to submit a single governing body resolution that covers the program application and the contract award.
